Temporary Rental Allowance

1. Determination 0503, Temporary Rental Allowance, is amended—

(a) by omitting paragraph 13 (a) and substituting the following paragraph:

“(a) 15 per cent of the rental ceiling specified in Schedule 2 of this Determination where the member's posting locality is Sydney; or”;

(b) by inserting in paragraph 13 (a) “Canberra (including Queanbeyan) or” after “locality is”;

(c) by omitting paragraphs 13 (a) and 13 (b) and substituting the following paragraphs:

“(a) 15 per cent of the rental ceiling specified in Schedule 2 of this Determination where the member's posting locality is Adelaide, Canberra (including Queanbeyan), Melbourne, Perth or Sydney;

- (b) 10 per cent of the rental ceiling specified in Schedule 2 of this Determination where the member's posting locality is Bendigo, Geelong, Portsea (Mornington Peninsula), Queenscliff, Rockingham, Sale or Salisbury; or
- (c) \$10.00 per week in any other case.”;
- (d) by inserting at the end of the entry relating to Canberra (including Queanbeyan) in Schedule 2—
“173 165 158 150 3 July 1986”; and
- (e) by inserting in Schedule 2 at the end of the entry opposite to a locality of posting shown in column 1 of the following table, the rental ceilings and specified date shown in column 2 of the following table opposite to that locality of posting:

Application

2. Determination 0503, Temporary Rental Allowance, as amended by—
- (a) paragraph 1 (a)—shall apply in relation to service by a member from and including 17 April 1986;
- (b) paragraphs 1 (b) and 1 (d)—shall apply in relation to service by a member from and including 3 July 1986; and
- (c) paragraphs 1 (c) and 1 (e)—shall apply in relation to service by a member from and including 7 August 1986.

EXPLANATORY STATEMENT

DETERMINATION NO. 70 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force

Determination 0503, Temporary Rental Allowance, provides for payment of an allowance to a member of the Defence Force who needs to rent accommodation for his or her family because a married quarter is not available. The rate of allowance is based on the difference between the weekly rental paid by the member (up to a specified rental ceiling applicable to the member) and a contribution by the member according to his or her rank group. In certain circumstances the determination permits an approving authority to increase the rental ceiling applicable to a member.

This determination amends Determination 0503 by increasing the amount by which an approving authority may approve an increase in the rental ceiling for a member who, due to family circumstances, is required to occupy a rented dwelling with more than 3 bedrooms:

- a. from a maximum of \$10.00 per week to a maximum of 15 percent of the normal limit where the member is residing in Adelaide, Canberra, Melbourne or Perth;
- b. from a maximum of \$20.00 per week to a maximum of 15 percent of the normal limit where the member is residing in Sydney; or
- c. from a maximum of \$10.00 per week to a maximum of 10 percent of the normal limit where the member is residing

in Bendigo, Geelong, Portsea, Queenscliff, Rockingham, Sale or Salisbury.

This determination also amends Determination 0503 by increasing the rental ceilings for Adelaide, Bendigo, Canberra, Geelong, Perth, Portsea (Mornington Peninsula), Queenscliff, Rockingham, Sale and Salisbury.

The date of effect is 17 April 1986 for the change to the Sydney provisions, 3 July 1986 for the changes to the Canberra provisions, and 7 August 1986 for the changes relating to other localities.
