8. Determination 3731, Meal Allowance Overseas, as amended by clause 4 of this Determination shall apply in relation to service by a member from and including 23 July 1986.

EXPLANATORY STATEMENT

DETERMINATION NO. 78 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 3601, 3610, 3711 and 3731 provide respectively for the payment of:

- a. Travelling Allowance;
- b. In Port Allowance;
- c. Settling In and Settling Out Allowance; and
- d. Meal Allowance Overseas,

to members of the Defence Force serving overseas to reimburse the travelling costs incurred or to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs involved because of that service overseas.

Clauses 1 and 5 of this determination amend Determination 3601, Travelling Allowance in its application to members serving in Spain:

- a. by increasing certain rates with effect from 23 July 1986; and
- b. by omitting certain other rates with effect from the date of signature of this determination.

Clauses 2 and 6 of this determination amend Determination 3610, In Port Allowance, by increasing, with effect from 23 July 1986, the rates payable to members serving in Spain.

Clauses 3 and 7 of this determination amend Determination 3711, Settling In and Settling Out Allowance, by increasing, with effect from 23 July 1986, the rates payable to members serving in Spain.

Clauses 4 and 8 of this determination amend Determination 3731, Meal Allowance Overseas, by introducing, with effect from 23 July 1986, a new rate of the allowance for Spain.
