Salary of Permanent Force Members

1. Determination 0101, Salary of Permanent Force Members, is amended by omitting from clause 35B all words after "payable to that member" and substituting "if that member were the Chief of Naval Staff."

Allowances of the Vice Chief of the Defence Force

2. Determination 0103, Allowances of the Vice Chief of the Defence Force, is amended by omitting from clause 2 all words after paragraph 2 (b) and substituting "that would be payable to that member if that member were the Chief of Naval Staff."

Application

3. This Determination shall apply in relation to service by a member from and including 1 July 1986.

EXPLANATORY STATEMENT

DETERMINATION NO. 79 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 0101, Salary of Permanent Force Members, in Division 1A and Determination 0103, Allowances of the Vice Chief of the Defence Force, provide that the Vice Chief of the Defence Force (VCDF) shall be paid the salary and allowances that would be payable in accordance with Determination No. 12 of 1985 of the Remuneration Tribunal made pursuant to sub-sections 7(3) and 7(4) of the Remuneration Tribunal Act 1973, if the member were holding the appointment of a Chief of Staff.

This determination amends Determinations 0101 and 0103 with effect from 1 July 1986 to provide that the VCDF shall be paid the salary and allowances which would be payable if the member were the Chief of Naval Staff.

The amendment operates to increase the salary and allowances of the VCDF to reflect the last National Wage increase; and to remove the requirement to periodically amend Division 1A of Determination 0101 and Determination 0103 to reflect movements in salary and allowances as determined from time to time by the Remuneration Tribunal.
