EXPLANATORY STATEMENT

DETERMINATION NO. 91 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 3601, 3610, 3711A and 3731 provide respectively for the payment of:

- a. Travelling Allowance;
- b. In Port Allowance;
- c. Settling In and Settling Out Allowance; and
- d. Meal Allowance Overseas,

to members of the Defence Force serving overseas to reimburse the travelling costs incurred or to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs involved because of that service overseas.

Clauses 1, 2 and 6 of this determination amend Determination 3601, Travelling Allowance:

- a. by introducing, with effect from 19 September 1986, new C rates for members serving in Greece who reside in hotel accommodation;
- b. by introducing, with effect from 23 September 1986, new B and C rates for members who reside in the Great Wall Hotel in China;
- c. by increasing, with effect from 29 August 1986, the rates payable to members serving in Pakistan;

- d. by increasing, with effect from 19 September 1986, the rates payable to members serving in Greece and the Sudan, and some of the rates payable to members serving in New Caledonia;
- e. by increasing, with effect from 23 September 1986, the rates payable to members serving in China other than members who reside in the Great Wall Hotel; and
- f. by decreasing, with effect from 27 November 1986, some of the rates payable to members serving in New Caledonia.

Clauses 3 and 7 of this determination amend Determination 3610, In Port Allowance:

- a. by increasing, with effect from 29 August 1986, the rates payable to members serving in Pakistan;
- b. by increasing, with effect from 19 September 1986, the rates payable to members serving in Greece;
- c. by increasing, with effect from 23 September 1986, the rates payable to members serving in China; and
- d. by decreasing, with effect from 27 November 1986, the rates payable to members serving in New Caledonia.

Clauses 4 and 8 of this determination amend Determination 3711A, Settling In and Settling Out Allowance:

- a. by increasing, with effect from 29 August 1986, the rates payable to members serving in Pakistan;
- b. by increasing, with effect from 19 September 1986, the rates payable to members serving in Greece and New Caledonia;
- c. by increasing, with effect from 23 September 1986, the rates payable to members serving in China other than members who reside in the Great Wall Hotel; and

- d. by introducing, with effect, from 23 September 1986, new rates of this allowance payable to members who reside in the Great Wall Hotel in China.

Clauses 5 and 9 of this determination amend Determination

3731, Meal Allowance Overseas:

- a. by increasing, with effect from 29 August 1986, the rates payable to members serving in Pakistan;
- b. by increasing, with effect from 19 September 1986, the rates payable to members serving in Greece and New Caledonia; and
- c. by increasing, with effect from 23 September 1986, the rates payable to members serving in China.
