EXPLANATORY STATEMENT

DETERMINATION No. 99 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

The following determinations provide for the payment of allowances to members of the Defence Force who are serving on duty overseas to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs incurred because of that overseas service:

- a. Determination 3714, Overseas Living Allowance;
- b. Determination 3718, Overseas Rental and Utilities Allowance;
- c. Determination 3723, Reunion Supplement; and
- d. Determination 3724, Child Supplement.

Clause 1 of this determination amends Determination 3714 to decrease, with effect from 25 December 1986, the rates payable to members serving in Japan, the Lebanon, Pakistan, the Solomon Islands or Vanuatu.

Clauses 2 and 5 of this determination amend Determination 3718 to decrease, with effect from 25 December 1986, the rent ceilings applicable to members serving with the United Nations in Egypt.

Clause 3 of this determination amends Determination 3723 to decrease, with effect from 25 December 1986, the rates payable to members serving in Egypt, Japan, Pakistan, the Solomon Islands or Vanuatu.

Clause 4 of this determination amends Determination 3724 to decrease, with effect from 25 December 1986, the rates payable to members serving in Egypt, Japan, Pakistan, the Solomon Islands or Vanuatu.
