EXPLANATORY STATEMENT

DETERMINATION NO. 79 OF 1987

ISSUED BY THE AUTHORITY OF THE MINISTER FOR INDUSTRIAL RELATIONS

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 0301, District Allowance, provides for the payment of an allowance to members of the Defence Force serving in certain localities specified as isolated districts because of their remoteness, extreme climatic conditions and the high cost of living.

Clauses 1 and 11 of this determination amend Determination 0301 to specify Montague Sound as a grade D isolated district attracting payment of the highest rate of allowance. The date of effect of this change is 6 October 1986.

Determination 3601, Travelling Allowance, Determination 3610, In Port Allowance and Determination 3731, Meal Allowance Overseas, provide for the payment of allowances to members of the Defence Force who are serving on duty overseas to reimburse, respectively, the additional travelling costs, incidental living expenses or meal costs incurred.

Clauses 2, 3, 4, 5 and 12 of this determination amend Determination 3601, Travelling Allowance:

- a. by increasing, with effect from 1 July 1987, some of the rates payable to members serving in Greece or India and all of the rates payable to members serving in Bangladesh, Yugoslavia or Zambia;

- b. by increasing, with effect from 3 September 1987, some of the rates payable to members serving in Finland or French Polynesia and all of the rates payable to members serving in New Zealand;
- c. by increasing, with effect from 17 September 1987, some of the rates payable to members serving in Algeria, Belgium, France or the United States of America (USA) and all of the rates payable to members serving in Tanzania;
- d. by decreasing, with effect from 29 October 1987, some of the rates payable to members serving in Algeria, Belgium, Brunei, Finland, France, French Polynesia, Greece or the USA and all of the rates payable to members serving in Israel, Saudi Arabia or Turkey;
- e. by specifying, with effect from the date on which this determination is signed, the rates for members serving in Syria in Syrian Pounds in lieu of the current United States Dollars;
- f. by omitting, with effect from the date on which this determination is signed, the "elsewhere" rates applicable to members serving in the USA; and
- g. by inserting, with effect from the date on which this determination is signed, a provision whereby the rates of Travelling Allowance specified for various localities in the USA are to be applied to certain other localities in the USA that are not specifically catered for in Determination 3601.

Clauses 6, 7 and 13 of this determination amend Determination 3610, In Port Allowance:

- a. by increasing, with effect from 1 July 1987, the rates payable to members serving in Bangladesh or Greece;
- b. by increasing, with effect from 3 September 1987, the rates payable to members serving in Finland or New Zealand;
- c. by increasing, with effect from 17 September 1987, the rates payable to members serving in Belgium, France or Tanzania;
- d. by decreasing, with effect from 29 October 1987, the rates payable to members serving in French Polynesia, Saudi Arabia or Turkey;
- e. by specifying, with effect from the date on which this determination is signed, the rates for members serving in Syria in Syrian Pounds in lieu of the current United States Dollars;
- f. by omitting, with effect from the date on which this determination is signed, the rates applicable to members serving in the USA and inserting new rates applicable to members serving in various different localities in the USA; and
- g. by inserting, with effect from the date on which this determination is signed, a provision whereby the rates of In Port Allowance specified for various localities in the USA are to be applied to certain other localities in the USA that are not specifically catered for in Determination 3610.

Clauses 8, 9 and 14 of this determination amend Determination 3731, Meal Allowance Overseas:

- a. by increasing, with effect from 1 July 1987, the rates payable to members serving in Bangladesh, Israel or Greece;
- b. by increasing, with effect from 3 September 1987, the rates payable to members serving in New Zealand;
- c. by increasing, with effect from 17 September 1987, the rates payable to members serving in Algeria, Tanzania or Honolulu or Los Angeles in the USA;
- d. by decreasing, with effect from 29 October 1987, the rates payable to members serving in Belgium, France, India or Turkey; and
- e. by inserting, with effect from the date on which this determination is signed, a provision whereby the rates of Meal Allowance Overseas specified for various localities in the USA are to be applied to certain other localities in the USA that are not specifically catered for in Determination 3731.

Determination 3901, Complementary Allowances Payable to Member Serving on Duty Overseas, provides for the reimbursement of a range of living costs incurred by a member of the Defence Force while serving in an overseas country.

Clauses 10 and 15 of this determination amend Determination 3901, Complementary Allowances Payable to Member Serving on Duty Overseas, by increasing, with effect from 6 August 1987, the rates of Household Maintenance and Assistance Allowance for members serving in Germany.
