**Determination under Section 58B of the
Defence Act 1903¹ (Amendment)**

I, ALLAN CLYDE HOLDING, the Minister of State for Employment Services and Youth Affairs, acting for and on behalf of the Minister of State for Industrial Relations, hereby make the following Determination under section 58B of the *Defence Act 1903*.

Salary of Permanent Force Members

1. Determination 0101, Salary of Permanent Force Members, is amended—

- (a) by omitting from paragraphs 7 (a) and 10 (a) all words and subparagraphs after “Department of” and substituting, in each case, “Industrial Relations titled First Assistant Secretary, Co-ordination and Conditions Division; or”;
- (b) by omitting from clause 8 “or 71”; and
- (c) by inserting after clause 8 the following clause:

“8A. For the purposes of clause 71, the approving authority shall be the person from time to time holding or performing the duties of the position in the Department of Industrial Relations titled First Assistant Secretary, Co-ordination and Conditions Division.”

Pay of Reserve Force Members

2. Determination 0199, Pay of Reserve Force Members, is amended—

- (a) by inserting in clause 4 “other than clause 18A,” after “Determination,”; and

(b) by inserting after clause 4 the following clause:

“4A. For the purposes of clause 18A, the approving authority shall be the person from time to time holding or performing the duties of the position in the Department of Industrial Relations titled First Assistant Secretary, Co-ordination and Conditions Division.”.

Education Allowance

3. Determination 0501, Education Allowance, is amended by omitting from paragraph 4 (c) and clauses 11 and 30 “Industrial Division” and substituting “Human Resources Division”.

Temporary Rental Allowance

4. Determination 0503, Temporary Rental Allowance, is amended by omitting paragraph 6 (c) and substituting the following paragraph:

“(c) for the purposes of clause 54—the person from time to time holding or performing the duties of the position in the Department of Industrial Relations titled First Assistant Secretary, Co-ordination and Conditions Division.”.

Temporary Accommodation Allowance

5. Determination 0504, Temporary Accommodation Allowance, is amended by omitting paragraph 5 (c) and substituting the following paragraph:

“(c) for the purposes of clause 35—the person from time to time holding or performing the duties of the position in the Department of Industrial Relations titled First Assistant Secretary, Co-ordination and Conditions Division.”.

Dwelling Purchase or Sale Expenses Allowance

6. Determination 0509, Dwelling Purchase or Sale Expenses Allowance, is amended by omitting paragraph 6 (a) and substituting the following paragraph:

“(a) in respect of clause 30, the person from time to time holding or performing the duties of the position in the Department of Industrial Relations titled First Assistant Secretary, Co-ordination and Conditions Division;”.

Outfit Allowance For Special Appointments

7. Determination 0606, Outfit Allowance For Special Appointments is amended by omitting from clause 5 all words after “Defence of” and substituting “Director General Service Conditions, Pay and Conditions Branch.”.

Child Education Allowance

8. Determination 3726, Child Education Allowance, is amended by omitting from clauses 9 and 16A “Industrial Division” and substituting “Human Resources Division”.

EXPLANATORY STATEMENT

DETERMINATION NO. 1 OF 1988

ISSUED BY THE AUTHORITY OF THE MINISTER FOR INDUSTRIAL RELATIONS

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Various determinations under section 58B of the Defence Act specify office holders within the Department of Defence who can exercise routine approving authority powers in the application of minor conditions of service matters.

This determination amends these determinations by:

- (a) introducing the First Assistant Secretary, Co-ordination and Conditions Division in the Department of Industrial Relations as an approving authority for the purposes of approving certain minor conditions of service in Determinations 0101, 0199, 0503, 0504 and 0509;
- (b) changing the name of one existing approving authority in the Department of Defence from the First Assistant Secretary, Industrial Division to the First Assistant Secretary, Human Resources Division for the purposes of approving matters relating to the payment of Education Allowance and Child Education Allowance under Determinations 0501 and 3726; and
- (c) omitting the name of one existing approving authority in the Department of Defence and introducing in its place the Director General Service Conditions, Pay and Conditions Branch as an approving authority for the

purposes of approving payment of clothing allowances to members of the Defence Force appointed for special positions under Determination 0606.

The date of effect of these changes is the date on which the determination is signed.
