 - (b) item 2 of the table in clause 3—shall apply in relation to service by a member on or after 23 June 1988.
8. Determination 3731, Meal Allowance Overseas, as amended by—
- (a) item 1 of the table in clause 5—shall apply in relation to service by a member on or after 21 January 1988; and
 - (b) items 2 and 3 of the table in clause 5—shall apply in relation to service by a member on or after 23 June 1988.

EXPLANATORY STATEMENT

DETERMINATION NO. 29 OF 1988

ISSUED BY THE AUTHORITY OF THE MINISTER FOR INDUSTRIAL RELATIONS

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

The following determinations provide for the payment of allowances to members of the Defence Force who are serving on duty overseas to reimburse their travelling and meal costs:

- a. Determination 3601, Travelling Allowance;
- b. Determination 3610, In Port Allowance;
- c. Determination 3711, Settling In and Settling Out Allowance; and
- d. Determination 3731, Meal Allowance Overseas.

Clauses 1, 2 and 6 of this determination amend Determination 3601:

- a. by increasing, with effect from 21 January 1988, the rates payable to members travelling in Egypt; and
- b. by decreasing, with effect from 23 June 1988, the rates payable to members travelling in Pakistan or the United Arab Emirates.

Clauses 3 and 7 of this determination amend Determination 3610:

- a. by increasing, with effect from 21 January 1988, the rates payable to members serving in Egypt; and
- b. by decreasing, with effect from 23 June 1988, the rates payable to members serving in Pakistan.

Clause 4 of this determination amends Determination 3711:

- a. by increasing, with effect from 21 January 1988, some of the rates payable to members serving in Pakistan and all of the rates payable to members serving in Egypt; and
- b. by decreasing, with effect from 23 June 1988, most of the rates payable to members serving in Pakistan.

Clauses 5 and 8 of this determination amend Determination 3731:

- a. by increasing, with effect from 21 January 1988, the rates payable to members serving in Egypt; and
- b. by decreasing, with effect from 23 June 1988, the rates payable to members serving in Pakistan or the United Arab Emirates.
