**Travelling Allowance**

1. Schedule 1 to Determination 3601, Travelling Allowance, is amended by omitting the entry relating to the Republic of Korea and substituting the following entry:

### Settling In and Settling Out Allowance

6. Determination 3601, Travelling Allowance, as amended by clauses 1 and 2 of this Determination shall apply in relation to service by a member on or after 24 December 1987.

7. Determination 3610, In Port Allowance, as amended by clause 3 of this Determination shall apply in relation to service by a member on or after 24 December 1987.

8. Determination 3731, Meal Allowance Overseas, as amended by clause 5 of this Determination shall apply in relation to service by a member on or after 24 December 1987.

EXPLANATORY STATEMENT

DETERMINATION NO. 5 OF 1988

ISSUED BY THE AUTHORITY OF THE MINISTER FOR INDUSTRIAL RELATIONS

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

The following determinations provide for the payment of allowances to members of the Defence Force who are serving on duty overseas to reimburse their travelling and meal costs or to enable them maintain a standard of living in an overseas country comparable to their standard in Australia by reimbursing the additional costs incurred because of that overseas service:

- a. Determination 3601, Travelling Allowance;
- b. Determination 3610, In Port Allowance;
- c. Determination 3711, Settling In and Settling Out Allowance; and
- d. Determination 3731, Meal Allowance Overseas.

Clauses 1, 2 and 6 of this determination amend Determination 3601 to increase, with effect from 24 December 1987, the rates of Travelling Allowance payable to members serving in the Republic of Korea.

Clauses 3 and 7 of this determination amend Determination 3610 to increase, with effect from 24 December 1987, the rates of In Port Allowance payable to members serving in the Republic of Korea.

Clause 4 of this determination amends Determination 3711:

- a. by increasing, with effect from 24 December 1987, certain rates of Settling In and Settling Out Allowance payable to members serving in the Republic of Korea; and
- b. by decreasing, with effect from 18 February 1988, certain other rates of Settling In and Settling Out Allowance payable to members serving in the Republic of Korea.

Clauses 5 and 8 of this determination amend Determination 3731 to increase, with effect from 24 December 1987, the rate of Meal Allowance Overseas payable to members serving in the Republic of Korea.
