EXPLANATORY STATEMENT

DETERMINATION NO. 11 OF 1989

ISSUED BY THE AUTHORITY OF THE MINISTER FOR INDUSTRIAL RELATIONS

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Sections 58B and 58E of the Defence Act 1903 allow the Minister or his delegate to make determinations on conditions of service for members of the Defence Force.

The following determinations provide for the payment of allowances to members of the Defence Force who are serving on duty overseas to reimburse their travelling and meal costs or to enable them to maintain a standard of living in an overseas country comparable to their standard in Australia by reimbursing the additional costs incurred because of that overseas service:

- a. Determination 3601, Travelling Allowance;
- b. Determination 3610, In Port Allowance;
- c. Determination 3711, Settling In and Settling Out Allowance;
- d. Determination 3731, Meal Allowance Overseas; and
- e. Determination 3901, Complementary Allowances Payable to Member Serving on Duty Overseas.

Clauses 1, 2 and 7 of this determination amend Determination 3601:

- a. by increasing, with effect from 5 January 1989, most of the rates for China;
- b. by increasing, with effect from 19 January 1989, the rates for Thailand and the United Arab Emirates and most of the rates for Korea;
- c. by increasing, with effect from 2 February 1989, the rates for Greece and Israel;

- d. by decreasing, with effect from 2 March 1989, some of the rates for China; and
- e. by decreasing, with effect from 16 March 1989, some of the rates for Korea.

Clauses 3 and 8 of this determination amend Determination 3610:

- a. by introducing, with effect from 19 January 1989 and 2 February 1989, rates of this allowance for, respectively, the United Arab Emirates and Israel;
- b. by increasing, with effect from 5 January 1989, the rates for China;
- c. by increasing, with effect from 19 January 1989, the rates for Thailand;
- d. by increasing, with effect from 2 February 1989, the rates for Greece; and
- e. by decreasing, with effect from 16 March 1989, the rates for Korea.

Clause 4 of this determination amends Determination 3711:

- a. by restructuring and increasing, with effect from 5 January 1989, most of the rates for China;
- b. by increasing, with effect from 19 January 1989, the rates for Korea and Thailand;
- c. by increasing, with effect from 2 February 1989, the rates for Israel; and
- d. by decreasing, with effect from 2 March 1989, some of the rates for China.

Clauses 5 and 9 of this determination amend Determination 3731:

- a. by increasing, with effect from 5 January 1989, the rates for China;

- b. by decreasing, with effect from 19 January 1989, the rates for Korea, Thailand and the United Arab Emirates; and
- c. by increasing, with effect from 2 February 1989, the rates for Greece and Israel.

Clauses 6 and 10 of this determination amend Determination 3901, with effect from 1 January 1989, to extend the payment of Club Allowance to unaccompanied Defence Force personnel serving on duty in Malaysia.
