EXPLANATORY STATEMENT

DETERMINATION NO. 12 OF 1989

ISSUED BY THE AUTHORITY OF THE MINISTER FOR INDUSTRIAL RELATIONS  
UNDER SECTION 58B OF THE DEFENCE ACT 1903

Sections 58B and 58E of the Defence Act 1903 allow the Minister or his delegate to make determinations on conditions of service for members of the Defence Force.

Determination 3498, Cadet Forces Allowances, provides for the payment of training, travelling and other like allowances to officers and instructors of the Cadet Forces.

This determination amends Determination 3498, with effect from 13 October 1988, to increase the maximum amount payable to such officers and instructors by way of certain allowances under the determination.
