Temporary Accommodation Allowance

1. Determination 0504, Temporary Accommodation Allowance, is amended:

(a) by inserting before the definition of "capital city" in clause 2 the following definition:

"allowance group", in relation to a member, means the allowance or group that is or would, if the member were entitled to Overseas Living Allowance, be applicable to the member under Determination 3714, Overseas Living Allowance,";

(b) by omitting from clause 15B "salary specified" and substituting "allowance group"; and

(c) by omitting Schedules 1 and 3 and substituting the following Schedules respectively:

EXPLANATORY STATEMENT

DETERMINATION NO. 2 OF 1989

ISSUED BY THE AUTHORITY OF THE MINISTER FOR INDUSTRIAL RELATIONS
UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 0504, Temporary Accommodation Allowance, provides for the payment of an allowance where a member and family are moved at Commonwealth expense from one locality to another in Australia and, because of that move, it is necessary to temporarily accommodate the member and family in a hotel or motel, or in a serviced apartment for a short period. Determination 3721, Rental and Utilities Contribution, allows the Commonwealth to deduct from the salary of a member serving overseas a specified amount, as the member's contribution towards the cost of residential accommodation in an overseas country.

Paragraphs 1(a) and 1(b) of this determination amend Determination 0504 by changing the classification of members used in Schedule 3 from a method based on salaries to rank based groups.

Paragraph 1(c) of this determination amends Determination 0504 by increasing the rates of board and lodging contributions which are contained in Schedules 1 and 3 and which a member is required to make towards the cost of the temporary accommodation.

Clause 2 of this determination amends Determination 3721 by increasing the rates of rent and utilities contribution which a member is required to make towards the cost of residential

accommodation in an overseas country.

The date of effect of the amendments is the first day of the pay period commencing on or after the date on which this Determination is made.
