EXPLANATORY STATEMENT

DETERMINATION NO. 9 OF 1989

ISSUED BY THE AUTHORITY OF THE MINISTER FOR INDUSTRIAL RELATIONS

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Sections 58B and 58E of the Defence Act 1903 allow the Minister or his delegate to make determinations on conditions of service for members of the Defence Force.

Determination 0303, High Electricity Charges Allowance, provides for the payment of an allowance to a member of the Defence Force who is charged exceptionally high rates for the electricity supplied to the premises which the member normally occupies with his or her dependants in isolated areas of Australia.

This determination revokes Determination 0303 as electricity tariffs in remote areas are now set at levels which equate to tariffs in other areas.

Determination 0304, Airconditioning Allowance, provides for the payment of an allowance to members of the Defence Force serving in specified localities to reimburse the cost of operating airconditioning facilities in their married quarters.

This determination revokes Determination 0304 as the determination has been replaced by a new Determination 0304, Airconditioning Allowance.

The date of revocation of both determinations is the date of signature of this determination.
