**DETERMINATION UNDER SECTION 58B OF THE DEFENCE ACT 1903**

**Citation**

1. This determination may be cited as Overseas Defence Determination 1990/1.

**Commencement**

2. This determination shall come into operation on the first day of the pay period commencing on or after the date of signature of this determination.

## Rates of Travelling Allowance - USSR

3. Determination 3601, as in force<sup>1</sup>, is amended by omitting from Schedules 1, 2 and 3 the rates of allowance in relation to the locality specified in Table 1 to this determination and substituting respectively the rates set out in Parts A, B and C of that table.

## Rates of In Port Allowance

4. Determination 3610, as in force<sup>1</sup>, is amended by omitting from the table in clause 5 the rates of allowance in relation to the locality specified in Table 2 to this determination and substituting the rates set out in that table.

## Settling In and Settling Out Allowances

5. Determination 3711, as in force<sup>1</sup>, is amended by omitting from the schedule the amounts in relation to the item specified in Table 3 to this determination and substituting the amounts set out in that table.

## Rates of Meal Allowance

6. Determination 3731, as in force<sup>1</sup>, is amended by omitting from the schedule the rates of allowance in relation to the locality specified in Table 4 to this determination and substituting the rates set out in that table.

EXPLANATORY MEMORANDUM

DETERMINATION NO. 1 OF 1990

Defence Act 1903

This determination amends Determinations:

- 3601 - Travelling Allowance
- 3610 - In Port Allowance
- 3711 - Settling In and Settling Out Allowance
- 3731 - Meal Allowance

The amendment provides for the payment of revised rates of allowances to members of the Australian Defence Force who are serving overseas in line with rates determined for Australian Public Service staff serving overseas.
