DETERMINATION UNDER SECTION 58B OF THE DEFENCE ACT 1903

Citation

1. This determination may be cited as Overseas Defence Determination 1990/49.

Commencement

2.1 Clause 6 of this determination shall be deemed to have come into operation in relation to each locality specified in column 1 of Table 2 to this determination on the day specified in column 2 of the Table opposite to the locality.

2.2 The remaining provisions of this determination shall come into operation 29 March 1990.

Revised rates of allowance

3.1 Determination 3714, Overseas Living Allowance, as in force¹ is amended, in relation to each item specified in Attachment 1 to this determination, by omitting from Schedule 2 each such item and substituting the corresponding entry set out in Part 1 of Attachment 1.

3.2 Determination 3723, Reunion Supplement, as in force¹ is amended, in relation to each item specified in Attachment 2 to this determination, by omitting from the Schedule each such item and substituting the corresponding entry set out in Part 1 of Attachment 2.

3.3 Determination 3724, Child Supplement, as in force¹ is amended, in relation to each item specified in Attachment 3 to this determination, by omitting from the Schedule each such item and substituting the corresponding entry set out in Part 1 of Attachment 3.

Transitional - payments in respect of relevant period

4.1 A member who, in respect of a country specified in Part 1 of Attachment 1 to this determination, was entitled to be paid Overseas Living Allowance in respect of the whole or part of the relevant period shall be entitled to be paid an allowance equal to the amount by which the sum of Overseas Living Allowance, Child Supplement and Reunion Supplement to which the member was entitled in respect of the whole or part of that period is exceeded by the sum of allowance and supplements which would have been payable to the member in respect of the whole or part of that period, as the case may be, if the rates of allowance specified in Part 2 of Attachment 1, Part 2 of Attachment 2 and Part 2 of Attachment 3 had been applicable with effect from the day specified in the attachment.

4.2 In this clause, the relevant period in relation to a country means the period ending on the day on which this determination comes into operation having commenced on -

- (a) if 2 or more dates of effect are specified in relation to the country in Part 2 of Attachment 1 - the earlier of those days; and
- (b) if a date of effect is specified in relation to the locality in Part 2 of Attachment 1 - the day so specified.

Rates for use of motor vehicles

5. Determination 3732, Overseas Vehicle Allowance, as in force¹ is amended, in relation to each country, and if applicable, locality, specified in Attachment 4 to this determination, by omitting from the Schedule the rates of allowance for each such country and locality and substituting the rates for that country and locality set out in Attachment 4.

Education assistance

6. Overseas Defence Determination 1989/27, as in force¹ is amended, in relation to each country, and if applicable, locality, specified in Attachment 5 to this determination, by omitting from Schedule 5 the rate of contribution for each such country and locality and substituting the rate for that country and locality set out in Attachment 5.
