Citation

1. This determination may be cited as Overseas Defence Determination 1990/5.

Commencement

2. This determination shall come into operation on the first day of the pay period commencing on or after the date of signature of this determination.

Settling In and Settling Out Allowances

5. Determination 3711, as in force¹, is amended by inserting in the Schedule, after item 87, the entry set out in Table 3.

Rates of Meal Allowance

6. Determination 3731, as in force¹, is amended by inserting in the schedule, in alphabetical order according to locality, the entry set out in Table 4.

EXPLANATORY MEMORANDUM

DETERMINATION NO. 5 OF 1990

Defence Act 1903

This determination amends Determinations:

- 3601 - Travelling Allowance
- 3610 - In Port Allowance
- 3711 - Settling In and Settling Out Allowance
- 3731 - Meal Allowance

The amendment provides for the payment of revised rates of allowances to members of the Australian Defence Force who are serving overseas in line with rates determined for Australian Public Service staff serving overseas.
