EXPLANATORY MEMORANDUM

**DETERMINATION NO. 9 OF 1990**

Defence Act 1903

Overseas Defence Determination 1989/198 amended various determinations to substitute revised rates of Overseas Living Allowance, Reunion Supplement and Child Supplement. The rates of allowance which were substituted were understated as the result of an error in calculation.

This determination makes the necessary amendments to introduce the correct rates with effect from the same date as the amendments made by Overseas Defence Determination 1989/198.
