Temporary Rental Allowance

1. Determination 0503, Temporary Rental Allowance, is amended by omitting from clause 6A "(a)(iii)" and substituting "(a)(ii)".

Meal Allowance

2. Determination 0506, Meal Allowance, is amended -

- (a) by omitting from sub-paragraph 10(a)(i) "\$8.00" and substituting "\$9.50";
- (b) by omitting from sub-paragraph 10(a)(ii) "\$10.00" and substituting "\$12.00";
- (c) by omitting from sub-paragraph 10(a)(iii) "\$13.00" and substituting "\$16.50";

- (d) by omitting from sub-paragraph 10(c) "\$10.00" and substituting "\$12.00"; and
- (e) by omitting from sub-paragraph 10(d) "\$4.00" and substituting "\$5.00".

EXPLANATORY STATEMENT

DETERMINATION NO. 99 OF 1990

ISSUED BY THE AUTHORITY OF THE MINISTER FOR INDUSTRIAL RELATIONS
UNDER SECTION 58B OF THE DEFENCE ACT 1903

Sections 58B and 58E of the Defence Act 1903 allow the Minister or his delegate to make determinations on conditions of service for members of the Defence Force.

Determination 0503, Temporary Rental Allowance, provides for payment of an allowance to assist with rental costs where a member of the Defence Force and family are removed at Commonwealth expense from one locality to another locality within Australia and they are obliged to rent accommodation at the new locality. The rate of allowance payable to a member is based on the maximum level of reimbursement of rental costs incurred by a member less a specified contribution by the member towards the rental.

Clause 1 of this determination makes a minor textual amendment to Determination 0503.

Determination 0506, Meal Allowance, provides for the payment of a meal allowance to enable members of the Defence Force to purchase meals where, for service reasons, the Commonwealth cannot provide them with meals to which they are entitled or where they are required to work extended or unusual hours over normal meal periods.

Clause 2 of this determination amends Determination 0506 to bring the Defence Force allowance into line with recent changes to the equivalent Australian Public Service allowance.

These changes takes effect from the date on which the determination is signed.
