1. This determination may be cited as Defence Determination 1991/1.

Commencement

2. This determination is to be taken to have commenced on 4 December 1990.

Principal Determination

3. In this determination, Determination 505, Disturbance Allowance, as in force is referred to as the Principal Determination.

Disturbance Allowance

4.1 Clause 8 of the Principal Determination is amended by omitting the table and substituting the following table -

EXPLANATORY MEMORANDUM

DETERMINATION NO. 1 OF 1991

Defence Act 1903

Determination 505, Disturbance Allowance, provides for payment of Disturbance Allowance to members of the Australian Defence Force moving from one locality to another at official expense. This determination increases rates in line with rates determined for Australian Public Service staff. The increases apply from the same date of effect.

The retrospective application of this determination does not affect the rights of a person (other than the Commonwealth) in a manner prejudicial to that person, nor does it impose any liability on such a person.
