DETERMINATION UNDER SECTION 58B OF THE DEFENCE ACT 1903

Citation

1. This determination may be cited as Overseas Defence Determination 1991/11.

Commencement

2. This determination commences on the first day of the pay period commencing on or after the date of signature of this determination.

Rates of Travelling Allowance - Jamaica

3. Determination 3601, Travelling Allowance, as in force¹ is amended by omitting from Schedules 1, 2 and 3 the rates of Travelling Allowance in relation to the locality specified in Table 1 of this determination and substituting respectively the rates set out in Parts A, B and C of that Table.

Rates of In Port Allowance - Jamaica

4. Determination 3610, In Port Allowance, as in force¹ is amended by omitting from the table in clause 5 the rates of In Port Allowance in relation to the locality specified in Table 2 of this determination and substituting the rates set out in that Table.

Settling In and Settling Out - Jamaica

5. Determination 3711, Settling In and Settling Out, as in force¹ is amended by omitting from the Schedule the rates of Settling In and Settling Out in relation to the item specified in Table 3 of this determination and substituting the rates set out in that Table.

EXPLANATORY MEMORANDUM

DETERMINATION NO. 11 OF 1991

Defence Act 1903

This determination amends Determinations:

- 3601 - Travelling Allowance
- 3610 - In Port Allowance
- 3711 - Settling In and Settling Out.

The amendment authorises revised rates of overseas travelling and related allowances for members at the localities referred to in the determination, in line with rates determined for officers of the Australian Public Service. The increase of 67% in rates (set in local currency) represents general cost increases, a change in the pricing source and the depreciation of the Jamaican Dollar.
