DETERMINATION UNDER SECTION 58B OF THE DEFENCE ACT 1903

Citation

1. This determination may be cited as Overseas Defence Determination 1991/12.

Commencement

- 2.1 Clause 4 of this determination is to be taken to have commenced in relation to each locality specified in column 1 of Attachment D to this determination on the day specified in column 2 of the Attachment opposite to the locality.
- 2.2 The remaining provisions of this determination commence on the first day of the pay period commencing on or after the date of signature of this determination.

Rates for use of motor vehicles

3. Determination 3732, Overseas Vehicle Allowance, as in force¹ is amended, in relation to each country, and if applicable, locality, specified in Attachment A to this determination, by omitting from the Schedule the rates of allowance for each such country and locality and substituting the rates for that country and locality set out in Attachment A.

Household maintenance and assistance allowance

4. The Schedule to Determination 3901, Complementary Allowances Payable to Member Serving on Duty Overseas, as in force¹ is amended by omitting each item specified in Attachment B to this determination and substituting the corresponding entry set out in Attachment B.

School transport

5. Overseas Defence Determination 1989/27 as in force¹ is amended, in relation to each country, and if applicable, locality, specified in Attachment C to this determination, by omitting from Schedule 5 the rate of contribution for each such country and locality and substituting the rate for that country and locality set out in Attachment C.

EXPLANATORY MEMORANDUM

DETERMINATION NO. 12 OF 1991

Defence Act 1903

This determination amends Determinations:

- 3732 - Overseas Vehicle Allowance
- 3901 - Complementary Allowances Payable to Member Serving on Duty Overseas
- 1989/27 - Education assistance.

The amendments provide for the payment of revised rates of allowances to members of the Australian Defence Force who are serving overseas in line with rates determined for Australian Public Service staff serving overseas.

The retrospective application of this determination does not affect the rights of a person (other than the Commonwealth) in a manner prejudicial to that person, nor does it impose any liability on such person.
