**Citation**

1. This determination may be cited as Overseas Defence Determination 1991/32.

**Commencement**

2. This determination commences on the first day of the pay period commencing on or after the date of signature of this determination.

### **Rates of Travelling Allowance - Spain**

3. Determination 3601, Travelling Allowance, as in force<sup>1</sup> is amended by omitting from Schedules 1, 2 and 3 the rates of Travelling Allowance in relation to the locality specified in Table 1 of this determination and substituting respectively the rates set out in Parts A, B and C of that Table.

### **Rates of In Port Allowance - Spain**

4. Determination 3610, In Port Allowance, as in force<sup>1</sup> is amended by omitting from the table in clause 5 the rates of In Port Allowance in relation to the locality specified in Table 2 of this determination and substituting the rates set out in that Table.

### **Settling In and Settling Out - Spain**

5. Determination 3711, Settling In and Settling Out, as in force<sup>1</sup> is amended by omitting from the Schedule the rates of Settling In and Settling Out in relation to the item specified in Table 3 of this determination and substituting the rates set out in that Table.

**DETERMINATION NO. 32 OF 1991**
