Commencement

2. This determination commences on the first day of the pay period commencing on or after the date of signature of this determination.

Rates of Travelling Allowance - USA - Guam

3. Determination 3601, Travelling Allowance, as in force¹ is amended by deleting the entries in Schedules 1, 2 and 3 for the country Guam and inserting, after the entries for USA - Houston, in Schedules 1, 2 and 3 respectively the entries set out in Parts A, B and C of Table 1 to this determination.

Rates of In Port Allowance - USA - Guam

4. Determination 3610, In Port Allowance, as in force¹ is amended by inserting in the table in clause 5, after the entry for USA - Houston, the entry in Table 2 to this determination.

Settling In and Settling Out - USA - Guam

5. Determination 3711, Settling In and Settling Out, as in force¹ is amended by inserting after item 93 in the Schedule the entry set out in Table 3 of this determination.

DETERMINATION NO. 4 OF 1991
