**Commencement**

### **Rates of In Port Allowance - Vietnam**

4. Determination 3610, In Port Allowance, as in force<sup>1</sup> is amended by omitting from the table in clause 5 the entry in relation to Vietnam and substituting the entry set out in Table 2 of this determination.

### **Settling In and Settling Out - Vietnam**

5. Determination 3711, Settling In and Settling Out, as in force<sup>1</sup> is amended by omitting from the Schedule the entry in relation to Vietnam and substituting the entry set out in Table 3 of this determination.

EXPLANATORY MEMORANDUM

**DETERMINATION NO. 41 OF 1991**

Defence Act 1903

This determination amends Determinations:

- 3601 - Travelling Allowance
- 3610 - In Port Allowance
- 3711 - Settling In and Settling Out.

The amendment authorises revised rates of overseas travelling and related allowances for members at the localities referred to in the determination, in line with rates determined for officers of the Australian Public Service.
