Citation

1. This determination may be cited as Overseas Defence Determination 1991/43.

Commencement

2. This determination is to be taken to have commenced on 1 March 1991.

Rates of Travelling Allowance - Kuwait

3. Determination 3601, Travelling Allowance, as in force¹ is amended by omitting from Schedules 1, 2 and 3 the rates of Travelling Allowance in relation to the locality specified in Table 1 of this determination and substituting respectively the rates set out in Parts A, B and C of that Table.

Rates of In Port Allowance - Kuwait

4. Determination 3610, In Port Allowance, as in force¹ is amended by omitting from the table in clause 5 the rates of In Port Allowance in relation to the locality specified in Table 2 of this determination and substituting the rates set out in that Table.

EXPLANATORY MEMORANDUM

DETERMINATION NO. 43 OF 1991

Defence Act 1903

This determination amends Determinations:

- 3601 - Travelling Allowance
- 3610 - In Port Allowance

The amendment authorises revised rates of overseas travelling and related allowances for members in Kuwait to take account of the special circumstances that currently apply in that country, in line with rates determined for officers of the Australian Public Service.
