### **DETERMINATION UNDER SECTION 58B OF THE DEFENCE ACT 1903**

#### **Citation**

1. This determination may be cited as Overseas Defence Determination 1991/49.

#### **Overseas Living Allowance**

**2.1** An officer who during the whole or part of the relevant period, was entitled to be paid Overseas Living Allowance applicable to an accompanied, unattached officer, in respect of a locality referred to in column 1 of the schedule to this determination is entitled to be paid in respect of the whole, or the part of the relevant period, as the case may be, an allowance at the rate in column 2 of the schedule opposite to the locality.

**2.2** In this clause the relevant period means the period commencing on 8 June 1989 and ending on 7 November 1990.

**EXPLANATORY MEMORANDUM**

**DETERMINATION NO. 49 OF 1991**

**Defence Act 1903**

This determination provides for payment of an allowance to certain members who were entitled to be paid Overseas Living Allowance during the period 8 June 1989 to 7 November 1990.

A computer system compliance audit undertaken by the Department using outside consultants revealed that the basis of calculation of Overseas Living Allowance was not in accordance with intended arrangements in some respects and some members were underpaid as a consequence. This variation from the intended rate was less than 0.75% of the allowance. The allowance payable under this determination makes the necessary adjustment to bring entitlements into line with the intended arrangements.

The period for which the determination applies commences from the date when the underpayment commenced and ends on 7 November 1990 when a revised formulation of Overseas Living Allowance was introduced – see Overseas Defence Determination 1990/191 and Public Service Determination 1990/229.
