**EXPLANATORY MEMORANDUM**

**DETERMINATION NO 60 OF 1991**

*Defence Act 1903*

This determination amends Determination 3901, Complementary Allowances Payable to Member Serving on Duty Overseas by providing for the payment of revised levels of household maintenance and assistance for members of the Australian Defence Force who are serving overseas in line with levels determined for Australian Public Service staff serving overseas.

The retrospective application of this determination does not affect the rights of a person (other than the Commonwealth) in a manner prejudicial to that person, nor does it impose any liability on such person.
