Citation

1. This determination may be cited as Overseas Defence Determination 1991/63.

Commencement

2. This determination commences on the first day of the pay period commencing on or after the date of signature of this determination.

Rates of Travelling Allowance – New Caledonia

3. Determination 3601, Travelling Allowance, as in force¹ is amended by omitting from Schedules 1, 2 and 3 the rates of Travelling Allowance in relation to the locality specified in Table 1 of this determination and substituting respectively the rates set out in Parts A, B and C of that Table.

Rates of In Port Allowance – New Caledonia

4. Determination 3610, In Port Allowance, as in force¹ is amended by omitting from the table in clause 5 the rates of In Port Allowance in relation to the locality specified in Table 2 of this determination and substituting the rates set out in that Table.

Settling In and Settling Out – New Caledonia

5. Determination 3711, Settling In and Settling Out, as in force¹ is amended by omitting from the Schedule the item specified in Table 3 of this determination and substituting the entry set out in that Table.

EXPLANATORY MEMORANDUM

DETERMINATION NO 63 OF 1991

Defence Act 1903

This determination amends Determinations:

- 3601 - Travelling Allowance
- 3610 - In Port Allowance
- 3711 - Settling In and Settling Out.

The amendment authorises revised rates of overseas travelling and related allowances for members at the localities referred to in the determination, in line with rates determined for officers of the Australian Public Service.
