DETERMINATION UNDER SECTION 58B OF THE DEFENCE ACT 1903

Citation

1. This determination may be cited as Defence Determination 1991/65.

Commencement

2. This determination is to be taken to have commenced on 1 April 1991.

Principal Determination

3. In this determination, Determination 0117, Special Royal Navy Allowance Paid to RAN Members Posted to and Serving in Britain, as in force¹ is referred to as the Principal Determination.

Special Royal Navy Allowance

4. Clause 5 of the Principal Determination is amended by -

- (a) omitting "Pound Stg 3.22", "Pound Stg 6.42" and "Pound Stg 81.00" in paragraph (b) and substituting respectively "£ Stg 3.95", "£ Stg 7.87" and "£ Stg 100.00";
- (b) omitting "Pound Stg 6.42" and "Pound Stg 159.00" in paragraph (c) and substituting respectively "£ Stg 7.87" and "£ Stg 195.00"; and
- (c) omitting "Pound Stg 6.42" and "Pound Stg 319.00" in paragraph (d) and substituting respectively "£ Stg 7.87" and "£ Stg 391.00".

EXPLANATORY MEMORANDUM

DETERMINATION NO. 65 OF 1991

Defence Act 1903

This Determination amends Determination 0117, Special Royal Navy Allowance Paid to RAN Members Posted to and Serving in Britain.

Determination 0117 provides for payment of allowances to certain members of the Navy who perform duties associated with deep experimental diving. These allowances are periodically adjusted to reflect equivalent allowances paid to members of the Royal Navy.

The amendment authorises revised rates of allowance with effect from 1 April 1991 in line with rates determined for Royal Navy members.

The retrospective application of this determination does not affect the rights of a person (other than the Commonwealth) in a manner prejudicial to that person, nor does it impose any liability on such person.
