Citation

1. This determination may be cited as Defence Determination 1992/1.

Part A

Principal Determination

2. In this Part Determination 507, Living Out Allowance, as in force¹ is referred to as the Principal Determination.

Admissible expenditure

- 3.1 Clause 5 of the Principal Determination is amended by omitting "and subject to clause 10".

3.2 Clause 6 of the Principal Determination is amended by omitting "and subject to clause 10".

Part B

Principal Determination

4. In this Part Determination 508, Living Out Away From Home Allowance, as in force² is referred to as the Principal Determination.

Admissible expenditure

5. Clause 6 of the Principal Determination is amended by omitting "and subject to clause 7,".

Admissible expenditure limited where hostel accommodation is available

6. The Principal Determination is amended by omitting clause 7.

Payment after occupancy ceases

7. Clause 17C of the Principal Determination is amended by omitting "Living Out Allowance" and substituting "Living Out Away From Home Allowance".

EXPLANATORY MEMORANDUM

DETERMINATION NO 1 OF 1992

Defence Act 1903

This determination amends Determination 507, Living Out Allowance, and Determination 508, Living Out Away From Home Allowance.

Clauses 3 and 4 of this determination amend Determination 507 by omitting redundant references to clause 10, which was omitted by Determination 1991/106.

Clause 6 of this determination amends Determination 508 by omitting clause 7 dealing with hostel accommodation because such accommodation is not used for Defence purposes. Clause 5 is a consequential amendment.

Clause 7 corrects the citation of an allowance.
