



## DETERMINATION NO 9 OF 1993

### DETERMINATION UNDER SECTION 58B OF THE DEFENCE ACT 1903

#### Citation

1. This determination may be cited as Defence Determination 1993/9.

#### Commencement

2. This determination comes into effect on 1 April 1993.

#### Principal Determination

3. In this determination, Determination 0117, Special Royal Navy Allowance Paid to RAN Members Posted to and Serving in Britain, as in force<sup>1</sup> is referred to as the Principal Determination.

#### Note

1. Determination 117 was made by Determination 30 of 1984 and has been amended by Determination Nos 52 of 1985; 15 of 1987; 17 of 1988; 88 of 1989; 141 and 166 of 1990; 65 of 1991; and 23 of 1992. The Determination has also been amended by Determination No 6 of 1987 made under section 58H.

## Special Royal Navy Allowance

4. Clause 5 of the Principal Determination is amended by -
- (a) omitting from paragraph (b) "£ Stg 4.19", "£ Stg 8.34", and "£ Stg 106.00" and substituting respectively "£ Stg 4.25", "£ Stg 8.47", and "£ Stg 107.59";
  - (b) omitting from paragraph (c) "£ Stg 8.34" and "£ Stg 207.00" and substituting respectively "£ Stg 8.47" and "£ Stg 210.10"; and
  - (c) omitting from paragraph (d) "£ Stg 8.34" and "£ Stg 414.00" and substituting respectively "£ Stg 8.47" and "£ Stg 420.21".

**EXPLANATORY MEMORANDUM**  
**DETERMINATION NO 9 OF 1993**

***Defence Act 1903***

This determination amends Determination 117, Special Royal Navy Allowance Paid to RAN Members Posted to and Serving in Britain.

Determination 117 provides for payment of allowances to certain members of the Navy posted to and serving in Britain, who perform duties associated with certain diving. These allowances are periodically adjusted to reflect equivalent allowances paid to members of the Royal Navy.

The amendments authorise revised rates of the allowance with effect from 1 April 1993 in line with rates determined for Royal Navy members.
