**EXPLANATORY MEMORANDUM**  
**DEFENCE DETERMINATION 1994/44**

*Defence Act 1903*

This Determination amends Determinations:

- 499 - Attendance Allowance
- 510 - Child Care Reimbursement Allowance
- 511 - Extra Tuition Allowance
- 601 - Uniform Maintenance Allowance
- 2501 - Charge for Rations and Quarters
- 1991/13 - Aide-de-Camp Allowance.

Parts B, C and D of this Determination provide for the payment to members of the Australian Defence Force (ADF) of increased rates of Attendance Allowance (+2.8%), Child Care Reimbursement Allowance (+4.4%) and Extra Tuition Allowance (+4.4%).

Parts E and G decrease rates of payment to members for Uniform Maintenance Allowance and Aide-de-Camp Allowance respectively (both -1.6%).

Part F provides for increased charges (+1.4%) to members for rations and quarters when members are provided with Service accommodation and meals.

These rates are adjusted annually in September, based on price movements in the relevant components of the Consumer Price Index for the year ending 30 June. The changes made by this Determination reflect price movements to June 1994. The adjustments in Parts E, F and G which have the effect of reducing entitlements have been introduced prospectively.

The retrospective application of this Determination does not affect the rights of a person (other than the Commonwealth) in a manner prejudicial to that person, nor does it impose any liability on such person.
