



OVERSEAS DEFENCE DETERMINATION 1994/53

DETERMINATION UNDER THE DEFENCE ACT 1903

1. Citation

1.1 This Determination may be cited as Overseas Defence Determination 1994/53.

2. Commencement

2.1 This Determination commences on the day on which Overseas Defence Determination 1994/52 commences.

3. Amendment

3.1 Determination 2802, Compensation for Loss of, or Damage to, Clothing or Personal Effects, as amended¹, is amended as set out in clause 4.

4. Clause 9 (Compensation not payable)

4.1 Delete "Determination 4003, Emergency Evacuation Overseas - Allowances and Compensation, made under section 58B of the *Defence Act 1903*", substitute "Overseas Defence Determination 1994/52 as in force from time to time".

5. Amendment

5.1 Determination 3714, Overseas Living Allowance, as amended², is amended as set out in clause 6.

6. Clause 6 (Disposable salary)

6.1 Definition of "disposable salary for Cost of Living Adjustment", paragraph (ea):

Delete "in accordance with clause 13 of Determination 4003, Emergency Evacuation Overseas - Allowances and Compensation", substitute "under clause 4 of Overseas Defence Determination 1994/52 as in force from time to time".

7. Repeal of Determination 4003

7.1 Determination 4003, Emergency Evacuation Overseas - Allowances and Compensation, as amended³, is repealed.

EXPLANATORY MEMORANDUM

OVERSEAS DEFENCE DETERMINATION 1994/53

Defence Act 1903

Overseas Defence Determination 1994/52 provides certain conditions of service relating to emergency situations and adverse circumstances for members of the Australian Defence Force on long-term posting overseas and, where applicable, their dependants.

Most of these entitlements were formerly authorised by Determination 4003, Emergency Evacuation Overseas - Allowances and Compensation.

This Determination repeals Determination 4003 and makes minor consequential amendments to two other determinations.

Clause 2 of this Determination provides for the Determination to commence on the same day as Overseas Defence Determination 1994/52.
