EXPLANATORY MEMORANDUM

DEFENCE DETERMINATION 1994/59

Defence Act 1903

Determination 505 provides for payment of Disturbance Allowance to members of the Australian Defence Force (ADF) moving from one locality to another at official expense.

This Determination amends Determination 505 by increasing the rates of Disturbance Allowance for ADF members by the same proportion and from the same date of effect as increases determined for Australian Public Service staff under section 82D of the *Public Service Act 1922*.

The retrospective application of this Determination does not affect the rights of a person (other than the Commonwealth) in a manner prejudicial to that person, nor does it impose any liability on such person.
