1. Citation

1.1 This Determination may be cited as Overseas Defence Determination 1994/6.

2. Commencement

2.1 This Determination commences on the day on which Overseas Defence Determination 1994/5 commences.

3. Repeal - Determination 3737

3.1 Determination 3737, Medical and Hospital Expenses of a Member's Family Overseas, as amended¹, is repealed.

4. Repeal - Determination 3738

4.1 Determination 3738, Dental Expenses of a Member's Family Overseas, as amended², is repealed.

EXPLANATORY MEMORANDUM

OVERSEAS DEFENCE DETERMINATION 1994/6

Defence Act 1903

Overseas Defence Determination 1994/5 provides for assistance with health services for dependants of members of the Australian Defence Force (ADF) on long-term posting overseas. That Determination operates by reference to identical conditions of service provided for officers of the Australian Public Service by Public Service Board Determination 1983/15.

The ADF provisions were formerly contained in Determinations 3737, Medical and Hospital Expenses of a Member's Family Overseas, and 3738, Dental Expenses of a Member's Family Overseas.

Clause 2 of this Determination provides for the Determination to commence on the same day as Overseas Defence Determination 1994/5.

Clauses 3 and 4 repeal Determinations 3737 and 3738.
