DETERMINATION 1 OF 1990

SALARY OF PERMANENT FORCE MEMBERS

Pursuant to section 58H of the Defence Act 1903, the Defence Force Remuneration Tribunal, having inquired into the salaries to be paid to senior members of the Defence Force following the National Wage Case decision of the Australian Industrial Relations Commission dated 7 August 1989, and the Defence Force having given commitments consistent with those required by the Commission, hereby determines that:

1. Determination 0101, Salary of Permanent Force Members, made by the Minister under Section 58B of the Defence Act 1903, and varied by determinations of the Defence Force Remuneration Tribunal, is further amended by omitting Schedule 1 and substituting Schedule 1 as set out herein.

2. A member who held the rank in column 1 and was in receipt of the salary specified in column 2 of the Table attached hereto on the 15th December 1989 and held the rank in column 3 and was in receipt of the salary specified in column 4 of the Table on the day before the date of effect of this Determination shall be entitled to the rate of salary specified for that same classification in column 5 of the Table from the date of effect of this Determination.

3. This Determination shall take effect from the beginning of the first pay period to commence on or after the date of this Determination.
