# DEFENCE FORCE REMUNERATION TRIBUNAL

## DETERMINATION NO 9 OF 1990

### PAY OF RESERVE FORCE MEMBERS

Pursuant to section 58H of the Defence Act 1903, the Defence Force Remuneration Tribunal, having inquired into the salaries to be paid to members of the Defence Force in relation to the Second Structural Efficiency Adjustment and Other Matters (Lance Corporal, Medical and Dental Officers and Chaplains), hereby makes the following determination.

#### Commencement

1. This determination is to be taken to have commenced on 19 July 1990.

#### Pay of Officers

2. Clause 15 of Determination 199, Pay of Reserve Force Members as in force is amended by inserting at the end of the clause the following sub-clause -

"(2) The classification of Chaplain Division 4B shall apply only to a member who is Head of Denomination."

#### Schedules of the Reserve Force Members

3. Determination 199, Pay of Reserve Force Members as in force is amended by omitting Schedules 2, 3, 4 and 6 and substituting respectively Schedules 2, 3, 4 and 6 to this determination.

#### Transitional

- 4.1 A Medical or Dental Officer with the rank of Captain who, immediately before this determination is taken to come into operation, was entitled to be paid salary at the rate specified in column 1 of the following table, shall be advanced to the corresponding salary point in column 2 of the following Table.


4.2 Where, but for this clause, the rate of salary payable to a Chaplain on the day on which this determination comes into operation would be less than the rate of salary payable to the member immediately before that day, the member shall be entitled to be paid salary at the second-mentioned rate.


