### DETERMINATION NO. 33 OF 1998

#### ROYAL AUSTRALIAN CORPS OF SIGNALS TRADE RESTRUCTURE

Pursuant to Section 58H of the Defence Act 1903, the Defence Force Remuneration Tribunal, having inquired into the Royal Australian Corps of Signals employment categories, hereby determines as follows:

1. Determination No. 6 of 1992, Salaries, being a determination made by the Defence Force Remuneration Tribunal pursuant to Section 58H of the Defence Act 1903, is amended by:

- (a) deleting from Schedule 1, Part B, Pay Group 4:  
Technician, Telegraph;
- (b) inserting into Schedule 1, Part B, Pay Group 1:

- (c) inserting into Schedule 1, Part B, Pay Group 2:

Operator Command Support Systems Grade 1,  
Operator Communications Grade 1;
- (e) inserting into Schedule 1, Part B, Pay Group 4:  
Assistant Supervisor Bearer Systems,  
Operator Command Support Systems Grade 2  
Operator Communications Grade 2,  
Supervisor Bearer Systems,  
Operator Electronic Warfare,  
Technician Telecommunication Systems;

(f) inserting into Schedule 1, Part B, Pay Group 5:

Assistant Detachment Commander Command Support Systems,  
Assistant Detachment Commander Communications,  
Assistant Detachment Commander Electronic Warfare,  
Assistant Detachment Commander Telecommunication Systems,  
Assistant Manager Bearer Systems,  
Detachment Commander Command Support Systems,  
Detachment Commander Communications,  
Detachment Commander Electronic Warfare,  
Detachment Commander Telecommunication Systems,  
Manager Bearer Systems,  
Supervisor Communications;

(g) inserting into Schedule 1, Part B, Pay Group 6:

Assistant Manager Communications,  
Assistant Supervisor Command Support Systems,  
Assistant Supervisor Electronic Warfare,  
Assistant Supervisor Telecommunication Systems;  
Manager Command Support Systems,  
Manager Communications,  
Supervisor Command Support Systems,  
Supervisor Electronic Warfare,  
Supervisor Telecommunication Systems;


(h) inserting into Schedule 1, Part B, Pay Group 7:

Assistant Manager Electronic Warfare,  
Assistant Manager Telecommunication Systems,  
Manager Electronic Warfare,  
Manager Telecommunication Systems.
