1. Citation

EXPLANATORY STATEMENT

PUBLIC SERVICE (DEFENCE) DETERMINATION 1999/3

Public Service Act 1922

This Determination amends Public Service (Defence) Determination 1999/1 (the Principal Determination) which authorises conditions of service for Australian Public Service officers of the Department of Defence performing duty overseas.

This Determination amends the Principal Determination to implement the results of a global review by the Department of Employment, Workplace Relations and Small Business of appropriate Meal Allowance and Travelling Allowance rates for officers performing duty overseas. Like the previous review implemented with effect from 1 March 1998, this review takes into account variations in prices and exchange rates at overseas localities.

Clause 3 of this Determination inserts a new Schedule 2 (Meal Allowance) to the Principal Determination.

Clause 4 inserts a new Schedule 3 (Travelling Allowance) to the Principal Determination.

This Determination commences on the day on which it is made, as provided by subsection 82D(8) of the *Public Service Act 1922*.
