EXPLANATORY STATEMENT

Public Service (Defence) Determination 1999/10

Public Service Act 1922

This Determination amends Public Service (Defence) Determination 1999/1, Overseas Conditions of Service, by varying the rates of Overseas Living Allowance (OLA) for certain overseas localities where officers are serving on long-term posting. The revised rates take account of variations in prices and exchange rate movements at the posts concerned.

Clauses 4 and 5 and Attachments A and B provide for the revised rates of OLA (including the Supplementary Allowances component) for the particular localities to be inserted into Schedules 7 and 8 to the Principal Determination. (It is noted that the rates of Supplementary Allowances for a post in Schedule 8 may not necessarily be varied when the rates of OLA for the post are varied in Schedule 7.)

This Determination commences on 25 November 1999, the first day of the next pay period following the day on which this Determination is made.
