



Delegated decision under the *Defence Employees Certified Agreement 2004-2006*

No. 3 of 2005, Travelling allowance, disturbance allowance, relocation assistance, motor vehicle allowance and pet relocation allowance

I, SUSAN JANE PARR, Director General Personnel Policy and Employment Conditions, acting in accordance with the delegation of powers to me under clause J4 of the *Defence Employees Certified Agreement 2004-2006* (DECA) by the Secretary to the Department of Defence, determine for the purposes of clauses I1 and I2 of Part I of DECA, that:

- (1) the rates of motor vehicle are adjusted in accordance with the rates listed in the following table;

ITEM	ENGINE CAPACITY (non-rotary)	ENGINE CAPACITY (rotary engine)	RATE cents per kilometre
1.	Above 2,600cc	Above 1,300cc	63
2.	1,601 to 2,600cc	801 to 1,300cc	62
3.	1,600cc and under	800cc and under	52

- (2) the rate of pet relocation allowance is to be adjusted to a maximum of \$159.00 per removal;
- (3) the rates of travelling allowance are to be adjusted in accordance with the rates listed at Schedule A to this decision;
- (4) the rates of disturbance allowance are to be adjusted in accordance with the rates listed at Schedule B to this decision;
- (5) the rates of temporary accommodation allowance – rent ceilings, are to be adjusted in accordance with the rates listed in Schedule C to this decision;
- (6) the rates of temporary accommodation allowance, travelling allowance on review and occupancy of a Commonwealth dwelling (excluding DHA housing) – rates for rental contribution payable by employees, are to be adjusted in accordance with the rates listed in Schedule D to this decision;
- (7) the rates of board and lodging allowance – rates of contribution, are to be adjusted in accordance with the rates listed in Schedule E to this decision;

(8) these adjusted allowance rates commence on 24 February 2005.
