Explanatory statement

Public Service (Defence) Determination 2000/4

This Determination amends Public Service (Defence) Determination 1999/11, Overseas Conditions of Service (the Principal Determination), by varying the rates of overseas living allowance (OLA) for most of the localities at which Australian Public Service employees of the Department of Defence are serving on long-term posting overseas. The revised rates of OLA take account of variations in prices and exchange rate movements at the localities.

The localities for which OLA is not varied by this Determination are: Fiji, Israel, Kiribati, Micronesia, Spain, the United Kingdom and Vanuatu.

Clause 1 of this Determination sets out the manner in which this Determination may be cited.

Clause 2 provides for this Determination to commence on payday 3 February 2000.

Clause 3 specifies that the amendments are made to the Principal Determination.

Clauses 4 and 5 omit the Schedules setting out rates of OLA and supplementary allowances respectively, and substitute revised Schedules.
