AGENDUM 40/10 – NATURE OF SERVICE FOR BORDER PROTECTION OPERATIONS

Reference:

- A. COSC Agendum 40/10 as considered by COSC on 29 Jun 10
1. COSC **noted** the Prime Minister's direction for retrospective nature of service determinations.
 2. COSC **agreed** that Option 3 presented in reference A is the preferred Defence position for border protection operations (BPO).
 3. COSC **agreed** the specific form of Option 3 and the grouping of BPO to be covered in the proposed submission to ERC be presented to COSC for decision in July 2010.
 4. CDF **directed** that attachment C to reference A, "Defence Operational Risk Assessment Scores – May 2010", is to be withdrawn from the paper as it does not reflect endorsed ADF policy.
 5. CDF **directed** DEPSEC DS to investigate the decision making process that led to additional leave being granted to members on border protection duties as a result of these operations being recorded as "non-warlike" on PMKeys.
 6. CDF **directed** DEPSEC PSP, in consultation with DEPSEC DS, to prepare a brief for
