Purpose:

To inform you of the significant events reported from ADF operational theatres covering the 24 hour period 0600K, 30 May 2011 to 0600K, 31 May 2011.

2. In an update to previous reporting (17 May 2011), the allegation of mistreatment made by detainee [REDACTED] when taken into custody on 10 May 2011 [REDACTED] has been investigated. The assault was witnessed [REDACTED] when the detainee and another individual suspected of behaving suspiciously were stopped [REDACTED]. A medical officer's examination corroborated the allegation. The internal investigation found the detainee's allegation of assault [REDACTED] was substantiated. The detention of [REDACTED] for his behaviour was appropriate, and the actions of ADF personnel in detaining [REDACTED] were in accordance with policy [REDACTED]. The investigation determined no further action was warranted. [SECRET]




