Application for Approval to Accept and Wear Foreign Awards

Instructions for completion

Subject to prescribed conditions, Australian citizens may accept and wear foreign awards when an offer is made by the Head of State or the Government of a country with which Australia maintains diplomatic relations, or by an official agency of the United Nations, or by other international organisations recognised diplomatically by Australia.

Permission for the formal acceptance and wearing of foreign awards can be given by the Governor-General, on the advice of the Prime Minister or the Minister for Defence.

Permission for the formal acceptance and wearing of foreign awards to ADF personnel will, in the first instance, be subject to advice from the Chief of the Defence Force or his or her delegate.

Proposals to give Australian citizens foreign awards shall be made in advance through recognised diplomatic or other official channels with full details of the reasons for the proposed award.

There is no objection to foreign awards presented without official permission being worn on the right breast at private functions, or at special services of commemoration or at ceremonies held in connection with that country.

Foreign awards which provide for the use of post nominals or titles in their country of origin will not be used by Australians.

Foreign awards are to be worn in accordance with The Order of Wearing Australian Honours and Awards.

The wearing of foreign awards by ADF personnel is subject to relevant single service dress regulations.

Assessment of eligibility for ADF personnel to wear foreign service awards will be based on a principle of performance.

Approval to wear foreign service awards will only be sought where that award has an equivalent within the Australian system of honours and awards.

Foreign service commendations do not have an equivalent within the Australian system of honours and awards, and therefore will not be considered for approval for wearing on an ADF uniform.

Proof of awards is to be in the form of a certified true copy of an official document.

Application to accept and wear foreign service awards by ADF personnel

Applications to accept and wear foreign service awards must be accompanied by proof of the award, full details of the reason for the award including dates and location of service.

Where ADF members were on exchange duty, the application is to be accompanied by proof of third country deployment where appropriate.

Application by ADF member to wear foreign Defence awards on ADF uniform

Application by ex-foreign Defence force personnel to wear awards on ADF uniform are to be accompanied by proof of the award and full details of the reason for the award, including dates and location of service.

Approval will not be given to wear awards which do not have an equivalent award with similar qualifying conditions in the Australian system of honours and awards, eg foreign long service awards for less than 15 years qualifying service.

Application by foreign Defence force member on exchange duty with ADF to accept and wear an ADF award

In all instances, approval is to be sought in advance for a foreign Defence force member to accept and wear an ADF award.

The application is to be accompanied by the member's service details, dates and location of qualifying service and the name of the award for which the member qualified.

Application by ADF member to wear non-military awards on uniform

Check single service dress regulations for guidance on wearing the award.

For awards within the Australian system of honours and awards not listed in single service dress regulations, approval is required from single service chiefs to wear the award.

Where single service dress regulations allow for wearing of an award, provide evidence of the award so that it can be recorded on service documents.
