**DEC03 – END USE AND NON
TRANSFER CERTIFICATE**

What is the purpose of the DEC03?

The DEC03 – End Use and Non Transfer Certificate authorises a consignee and end user to receive goods and or technology for an approved end use, on the condition that they will not re-export, resell or otherwise transfer, the goods and/or technology without the consent of the Australian Minister for Defence or their delegate.

When do I need to submit a DEC03?

When you are submitting an *Application to Export or Supply Controlled Goods and Technology* **and**:

- the goods and/or technology are on the Sensitive or Very Sensitive list in the *Defence and Strategic Goods List*; **or**
- have a military end-use; **or**
- Defence Export Controls has requested a DEC03 based on the circumstances of your application.

Who needs to complete and sign a DEC03?

An authorised agent of the **Applicant** (*i.e. the exporter*) must complete and sign all fields in the Applicant section of this DEC03.

An authorised agent of the **Consignee** (*a third/intermediary who is part of the supply chain for the export of the goods and/or technology. For example, a distributor or transport company*) must complete and sign the Consignee section of this DEC03 (if the consignee is NOT the same as the End User). All fields must be completed and the Certification of Consignee section signed.

An authorised agent of the **End User** (*i.e. the person/company that will receive and use the goods and/or technology*) must complete the End User and End Use sections, and complete and sign the Certification by End User of this DEC03.

How should I submit my DEC03?

The **Applicant** should attach a scanned copy of the DEC03 when submitting an *Application to Export Controlled Goods and Technology* via the *Forms Website*.

 - g. where the Consignee believes or suspect that the goods and/or technology will or may potentially be used in a weapons of mass destruction (WMD) program, I will immediately contact Defence Export Controls on +61 2 6266 7222 or via email exportcontrols@defence.gov.au

 - d. the goods and/or technology will not be re-exported, resold or otherwise disposed of, to any other party or destination, without the permission of the Australian Defence Minister or their delegate, **AND**
 - e. the goods and/or technology will not be used in the development, production or use of chemical, biological or nuclear weapons or for missiles capable of delivering such weapons; **AND**
 - f. the goods and/or technology will not be used to commit or facilitate serious violations of humanitarian law or human rights law; **AND**
 - g. the Australian Government or its representatives may conduct post-shipment inquiries to verify that the end use of the goods complies with the export permission, including this DEC03.
