**DEC09 – FIREARM(S)/AMMUNITION
END USE CERTIFICATE GUIDELINES**

What is the purpose of the DEC09?

The Australian Government monitors and controls the export of firearms and related goods. Firearms, ammunition, firearm parts and accessories, regardless of their state, completeness or working condition, are subject to export controls under Commonwealth legislation.

The DEC09 – Firearm(s)/Ammunition End Use Certificate certifies that the End User (that is, the person/company that will receive and use the firearm(s)/ammunition, parts and/or accessories) is **the final recipient** of the listed firearm(s)/ammunition, parts and/or accessories exported from Australia, and will not re-export, sell or otherwise dispose of them without the consent of a Police Commissioner, or an appropriate Government Authority, in the country of destination.

When do I need to submit a DEC09?

When you are submitting an *Application to Export or Supply Controlled Goods and Technology* and:

- the export of firearms, ammunition parts and/or accessories is to any of the following destinations: *Federated States of Micronesia, Fiji, Kiribati, Marshall Islands, Nauru, New Caledonia, Niue, Palau, Papua New Guinea, Samoa, Solomon Islands, Timor-Leste, Tonga, Tuvalu and Vanuatu**; or
- Defence Export Controls has requested a DEC09 based on the circumstances of your application.

* At the request of the Government of Vanuatu, DEC will only process applications for firearms exports from Australia to Vanuatu to the following approved consignees – Port Vila Hardware, LCM Store and Chew Store. Should exporters have any questions regarding this change, please contact Defence Export Controls (DEC).

Who needs to complete and sign a DEC09?

The **Applicant** (*i.e. the Australian exporter*) is to complete the top section of the DEC09 and forward to the End User to complete all other sections. If the Applicant is also the End User, please ensure all sections of the form are completed and signed.

The **End User** (*i.e. the person/company that will receive and use the firearm(s)/ammunition*) must complete all sections of the form up to and including the 'Certification by Firearm(s)/Ammunition End User'. It is also the End User's responsibility to obtain the endorsement of the Police Commissioner, or the appropriate Government Authority, of the destination country (*i.e. the country to which the goods will be exported*). **Please note that all signatures must be handwritten.**

How should I submit my DEC09?

The **Applicant** should send a scanned copy of the DEC09 when submitting an *Application to Export Controlled Goods and Technology* to exportcontrols.applications@defence.gov.au
