Noting the recent UAM activity in the US, the applicant **s47F** has shown a keen interest in requesting information in relation to UAM's. With that said, reference FOI 459/21/22 – Redacted – Cleared for release to applicant; Space Command have suggested that the personnel listed in the documents would become a target for future FOI requests should names contained with the documents be released. Space Command have applied redactions to personnel inclusive of 1 Star and above.

With reference to the document at the attached link 459/21/22 – Proposed redactions; On the topic of disclosing the names and contact details of public servants, the Office of the Information Commissioner states the following;

• "The Information Commissioner remains of the view that generally it will not be unreasonable to disclose the names and contact details of public servants because this information only reveals that they were performing their public duties. The Information Commissioner considers there are public interest factors, including transparency and accountability of public servants, which favour disclosure of this kind of information". "However, there are circumstances that may lead to real risks to the health, safety and wellbeing of some staff resulting from disclosure of this information"

While I do understand Space Commands position, I do not believe there is what would be consider to be a "real risk to the health, safety and wellbeing of staff", however as the ADM I would appreciate your thoughts with respect to the non-disclosure of personnel names inclusive of 1 Star and above.

Please note AVM Roberts has cleared the TP's and documents for release with applied redactions. Any changes made to the final document pack will be required to go back through AVM Roberts for clearance.
