FORGEN

16. FORGEN covers all REGT exercises, 2 CER exercises and DACC CONFE. In each instance, the FORGEN is to be aligned with the minimum level of capability requested. For most instances with 2 CER exercises, this will consist of a full troop, including TP HQ elements and may have an addition of a section (+) of construction. All personnel nominating for the FORGEN exercises and CONFE are to:

- a. Be fully qualified for rank and trade
- b. Hold a deployable MEC
- c. Have nil IR deficiencies and
- d. Have completed mandatory training.

18. **DACC CONFE:** The CONFE for DACC tasking is to be managed at RHQ. The FE is to be task organised for the roll they are to be deployed into. These tasks are normally short notice and will require each SQN to maintain and manage a recall list of personnel based on skill set and anticipated availability.

19. **During the RTP.** The responsibility for deploying FE for DACC tasking will reside with the OPSO at RHQ in the first instance. SQN FE lists are to be maintained in MAPS Manager.

SITUATION

1. 5 ER is to conduct EX HOLDFAST MUSTER over the period 23 – 24 NOV 19 within SQN LOCS as a decentralised activity. This activity will focus on mandatory training and AIRN compliancy requirements IOT provide 'ready' force elements throughout the year. Further to this, any additional collective and individual administrative requirements will be completed during this period including but not limited to the following:

- a. Mandatory Training for those attending
- b. AIRN (BFA and WTTS)
- c. Preparing SQN Locations for RTP
- d. Preparing SQN FE for Engineer Support Force (ESF) response to Government (DACC) on order
- e. Completing any other Administration required before Army goes into RTP

MISSION

2. 5 ER is to conduct EX HOLDFAST MUSTER over the period 23-24 Nov within SQN Locations IOT set the conductions for individual and collective readiness from Dec 2019.

EXECUTION

3. **Purpose.** The requirement to meet the CA intent for individual preparedness is essential for the continued readiness of the Regt through the Reset year. This individual readiness includes, but not limited to the completion of Mandatory Training, AIRN preparedness and the preparation of essential SQN equipment to prepare for ESF response on order and preparing SQN locations for BDE RTP.

4. **Method.** This will be achieved through the following decisive events (DE):

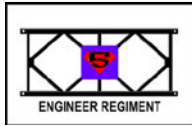

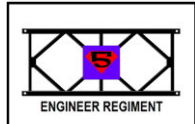
