- The Terms of Reference refer to the Taskforce undertaking an assessment of the opportunities for a strategic fleet to contribute to supporting Defence or national mobilisation requirements.
- Mobilisation is the process of generating capability and marshalling national resources.
 - Mobilisation has meant the support of military operations for national defence, but could include coordinated national response to significant non-military crises.
- Maritime vessels (depending on parameters) could assist mobilisation by transporting cargo or personnel between Australian ports.

Additional information related to mobilisation

- Mobilisation can occur as a graduated response across four stages. In its final stage, national
 mobilisation occurs in the face of a significant threat to the nation and requires total Defence
 mobilisation and government coordination of a national effort to enable profound re-direction of
 national support base capability to achieve national objectives. Defence mobilisation for national



INTRODUCTION

1. The Department of Defence (Defence) welcomes the opportunity to contribute to the Taskforce discussion paper into the Maritime Strategic Fleet.

2. Defence has fundamental linkages to the Australian shipping industry in terms of maritime security, commercial sea lift, maritime workforce and maritime infrastructure. It is vitally important to maintain engagement between Defence and key government and commercial stakeholders to ensure that Defence requirements are considered.

3. This submission aims to inform the Taskforce of Defence considerations for a Strategic Fleet, including potential ways in which a Strategic Fleet might support Defence activity.

STRATEGIC NEEDS

4. Strategic Sealift is a key Defence requirement, stated in core Defence policy including the Defence White Paper 2016, Defence Strategic Policy Statement on Air and Sea Lift of 2018 and the Defence Strategic Update 2020. The need has been developed over time and is supported by a number of studies. The Defence Strategic Review is currently in progress and may change priorities and alter details of the requirement but is unlikely to remove the need for strategic lift.

The Defence Act 1903² provides the Government the ability to compel owners of Australian registered ships to furnish them to the Australian Defence Force (ADF) for the purpose of the defence and protection of the Commonwealth or of any state.

29. Commercial ships on Government non-commercial duty qualify for sovereign protection as declared Naval Auxiliaries, and fly the Australian Flag (White Ensign). Such arrangements are already managed for the Defence Marine Support Services ships in Australian jurisdictions, via agreements with the Australian Maritime Safety Authority (AMSA) or under Defence Seaworthiness Management Authority.

30. Acknowledging these provisions, there are two important factors which impact the practicality of their application; the threshold at which these powers would be enacted, and the paucity of suitable Australian registered shipping. If Australian ships were to be requisitioned it would likely have an immediate economic and social impact on the



populations that previously relied upon that service. Accordingly the Government would need to carefully consider application of these powers.

31. Under Section 70 of the Defence Act (1903), and associated Deeds of Licence Australian Defence Force vessels are afforded privileged access to Australian ports. This can translate as port access free from berthing or anchorage charges. All other normal fees associated with ports such as the provision of harbour pilots, fresh water, power, provisions and waste removal are charged to Defence in the same way as any other commercial customer. Defence is also liable, where appropriate, for demurrage charges when an ADF vessel requires priority access to a specific berth that is currently occupied by a commercial customer. It should be noted that this requirement is uncommon and where possible Defence seeks to minimise impact on commercial vessel movement and trade. The provisions and exemptions of s.70 of the Defence Act 1903 can also extend to those foreign navies listed in Schedules 1 and 2 of the Defence (Visiting Forces) Regulations 1963. The Taskforce should consider the application of these arrangements to a Strategic Fleet for Defence tasks.





Defence Position on the Proposal to Establish a Strategic Fleet

Key Issues:

In June 2023 the Strategic Fleet Taskforce delivered its final report (the Report). The Minister for Infrastructure, Transport, Regional Development and Local Government, the Hon. Catherine King MP will consider the Report and proposed response, which Defence understands identifies ship options and other needs. The Strategic Fleet's utility to Defence will depend on scale, composition, commercial arrangements and priorities. Establishment of a Strategic Fleet is not specifically mentioned in the Government's response to the Defence Strategic Review (DSR), however there are interdependencies between the proposed Strategic Fleet, and DSR initiatives. Defence supports the establishment of a Strategic Fleet if funded external to the Defence budget, ensuring Defence is able to prioritise capabilities directed by the Government.

Media Considerations:

Proposed establishment of a Strategic Fleet and Defence considerations have attracted media attention. No media attention is expected as a result of this brief.

Whilst the establishment of a Strategic Fleet could support a number of DSR recommendations agreed by the Government, particularly those relating to logistics and support to disaster relief, s47C s47C
- 21. The Government's National Defence Statement 2023 noted that the recommendations of the DSR work in concert with other Government Policy priorities which enhance our security and build our economic resilience, of which the Strategic Fleet is one. The interdependencies between the two reviews include the ability of the Strategic Fleet to:
 - a. support the development of Australia's strategic, industrial and military logistics capabilities in alignment with the need identified in the DSR for a national logistics support concept;
 - b. help secure fuel supply chains as part of a whole-of-government Fuel Council;


